VILLAGE OF CHIPPEWA-ON-THE-LAKE
ORDINANCE NO. 407-91

AN ORDINANCE AMENDING ORDINANCE NUMBER 315-81, CURFEW FOR MINORS, AND DECLARING THE SAME AN EMERGENCY.

WHEREAS:

The Village Council has determined that the Curfew Ordinance should be amended to be consistent with the curfew in effect in the Village of Briarwood Beach and in order to provide more effective enforcement of the curfew by the Briarwood Beach Police Department.

NOW, THEREFORE, IT IS ORDAINED by the Council of the Village of Chippewa-on-the-Lake, County of Medina, State of Ohio, three-fourths of its members concurring herein, that Ordinance Number 315-81 is amended to the following:

SECTION I:

Any juvenile, under the age of eighteen years, whether residing in the Village or elsewhere, unless accompanied by his or her parent, guardian or other person of adult age who is charged with the full responsibility of the juvenile, his or her welfare and all of his or her activities, is prohibited from the public sidewalks, public streets, or property of the Village of Chippewa-on-the-Lake during the following times:

- a) from 11:00 p.m. on Sunday, Monday, Tuesday, Wednesday, and Thursday until 5:00 a.m. on the following day; and
- b) from 12:00 midnight on Friday and Saturday until 5:00 a.m. on the following day.

SECTION II:

No person, being the parent, guardian or otherwise responsible for the care, control or custody of a minor child, shall permit or neglectfully allow the child to be abroad on the public sidewalks, public streets or other property and public places of the Village of Chippewa-on-the-Lake in violation of Section I of this Ordinance, unless such person personally accompanies such minor child or provides that a responsible person eighteen years of age or older accompanies such minor child.

SECTION III:

Whoever violates Sections I or II of this Ordinance is guilty of a minor misdemeanor.

SECTION IV:

This Ordinance is declared to be an emergency measure necessary for the public peace, health, safety and welfare of the Village of Chippewa-on-the-Lake and its inhabitants in order to provide for immediate conformity of the curfew in this Village with that in effect in the

Village of Briarwood Beach for effective enforcement of the same by the Briarwood Beach Police Department in both Villages, and shall go into immediate operation and effect.
