Water Testing Reveals High Levels of E. coli in Chippewa Lake

Chippewa Lake remains closed to all activities due to heightened levels of E. coli bacteria caused by recent flood events. The closure is unrelated to the COVID-19 coronavirus outbreak.

The lake was closed after heavy rainfall resulted in flooding twice within the past three weeks. In keeping with a longstanding safety protocol implemented by the villages of Chippewa Lake and Gloria Glens, as well as the Medina County Health Department, Medina County Sanitary Engineer, and the park district, E. coli testing must take place before the lake can be reopened.

Water samples collected by the Medina County Health Department on April 10 at two separate locations on the lake showed E. coli levels at more than twice the acceptable limit for public safety. A follow-up test will be scheduled for the week of April 20. For information on E. coli bacteria and human health, please visit the Ohio Department of Health website at <u>www.odh.ohio.gov</u>.

License Plate / Driver's License Renewals EXTENDED

Governor DeWine ordered that Ohio licenses (including driver's license, CDLs and license plate registrations) expiring during the declared state of emergency shall remain valid until either 90 days after the declared emergency ends, or December 1st, 2020, whichever comes sooner. The State of emergency was declared on March 9, 2020

EMERGENCY ALERTS TO YOUR CELL OR HOME

A few residents have asked why the weather sirens were only faintly heard or not heard at all during the weather emergency on April 7, 2020.

Lafayette Township has two sirens in Chippewa Lake and one at the intersection of Lafayette and Wedgewood Roads which are tested the first Saturday of each month. These sirens are designed to be

heard outside only. They are activated by the Sheriff's Office and only for specific weather events. These sirens should not be relied upon for indoor safety.

The reliable choice: If you want to receive emergency alerts of all types and directly to your cell and/or home, Medina County residents can register for WENS (Wireless Emergency Notification System) which allows safety officials to send emergency messages to the entire community, or a specific area within moments. These messages will inform you of the situation and give instructions for action.

WENS delivers messages by phone call, text message and email based on the contact information you provide. The service is used only for emergency notification when rapid and accurate information is essential for your immediate safety.
